**Subject :- Exemption u/s 80-G of the Income Tax Act, 1961**

It is hereby ordered that donations made "M/s Swami Indravesht Saraswati Memorial Vidhya Peeth, Charitable Trust, Kevlanand Nigam Ashram Ganj Daranagar, Bijnor" shall qualify for deduction u/s 80G of the Income Tax Act, 1961 in the hands of the donors subject to the limit prescribed.

- i. This exemption is valid from 19.01.2009 to 31.03.2011 relevant to assessment year 2009-10, (partly) 2010-11, & 2011-12 subject to the following conditions :
- ii. Receipts issued to the donors should bear the number and date of this order and should state clearly that this certificate is valid upto 31.03.2011 only.
- iii. The Income and Expenditure Account and Balance Sheet should be submitted annually to the Assessing Officer having jurisdiction over the case.
- iv. The amendments, if any made to the memorandum of association should be intimated to this office immediately.
- v. If any renewal is required, an application has to be made in the prescribed proforma within 3 months from the end of the date of exemption to this office along with statement of accounts of income and expenditure for the last 3 years and copy of bye laws and Memorandum of Association etc
